The author(s) hereby confirm(s) that they are the sole author(s) of the contribution, that he/they is/are entitled to grant the following licenses and that he/they has/have so far not transferred any rights which would be in conflict with the licenses under this agreement to third parties.

The author(s) hereby transfer(s) to VDE VERLAG GMBH, Berlin and Offenbach, the following rights to the above referenced contribution:

the right to publish in the conference publication,

the right to copy and distribute (publishing right),

the right for electronic publication including the necessary modifications, the storage on electronic media, the download and the provision in an online data base,

the right to use the contribution for presentations, for the design of the conference publication and for promotional activities regarding the conference publication and the publishing house.

CONSENT TO DATA PROCESSING AND APPROVAL OF PHOTO AND FILM RECORDINGS

NOTE ON THE RIGHT OF WITHDRAWAL

Once registered, the participants of the NEIS conference have the right to revoke the conclusion of the contract with the organizer within 14 days of receipt of the confirmation of registration.

A justification for the withdrawal is not needed. To meet the deadline, it is sufficient to send the declaration of withdrawal within the 14 days (date of postmark / e-mail).
