Scientific Methodology:

- The paper should clearly explain the applied scientific methodology in a conclusive and sophisticated manner.
- The mathematical modelling should be sufficiently presented, with appropriate formulas that describe the modelling and investigated parameters, and a clear description of the mathematical approach and its synthesis.

Analysis and Conclusions:

- The practical or logical evaluation of the results should be comprehensible and convincing to support logical and convincing conclusions.
- Any new ideas presented in the paper should be logical and convincing, with a sufficiently explained novel approach.

Paper Overview:

- The abstract should clearly describe the goal of the paper, including any new ideas or the relevance of a review-type paper.
- The keywords should be relevant and actually mentioned in the text.
- The introduction should introduce the main train of thought based on past research results.
- The title should be suitable for someone performing related research to discover the article in a search engine or on IEEE Xplore.

Significance of the Paper:

• The paper should sufficiently explain its significance, especially in relation to previous work, by comparing and differentiating it from other relevant approaches.

References and Presentation:

- The cited literature should be relevant, with the majority of references being primary resources that can be accessed via university libraries and have ISBN, DOI-Numbers, or any other official number from public institutions (IEEE Xplore, specialist books, SpringerLink, VDE, etc.).
- Internet resources should only provide additional information.

- For papers published in translation journals, please give the English citation first, followed by the original foreign-language citation in brackets. Please consider the given example:

Writing Quality:

- The paper should have no grammar or spelling errors.
- Math symbols and formulas should be explained and comprehensible.
- The paper should be easily readable.
- Use US-English in writing your paper.
- The axis labels should be formatted consistently. For example, if the axis represents the current, the label could be formatted as either "I/A" with the I italicized and the unit in normal font. When fractions are necessary, use a different formatting such as "σ / C·cm⁻²" to avoid confusion.
- Use PNG files with at least 300 dpi resolution for all images in the paper.
- Use italics for indices and subscripts in mathematical equations to maintain consistency.
 For specific designations like the Boltzmann constant, use italics for K and normal for B consistency.

Submission Requirements:

- The submission should be in Word and PDF formats.
